This charter sets out Boralex's and its suppliers' commitments for responsible procurement through a sustainable relationship between the parties.

Our commitments for responsible procurement

To promote a responsible supply chain and sustainable performance to support our operations, Boralex is guided by three pillars:

1. Develop innovative partnerships with suppliers

Innovate by building partnerships with suppliers that help them integrate into new services and the circular economy.

2. Improve competitiveness

By building mutually beneficial relationships with suppliers and forging transparent relationships and win-win partnerships.

3. Help drive local development

Through our contribution to development in the areas we operate in, by supporting not-for-profit organizations or sports and cultural associations.

Boralex is committed to continuously improving its environmental and social performance through frequent reviews of its policies and procedures.

The commitments of our suppliers:

Boralex expects its suppliers to contribute to overall value creation and environmental and social performance with respect to sustainable development.

To achieve this, our suppliers undertake to:

- 1. Uphold the fundamental rights set forth in the <u>Universal Declaration of Human Rights</u> and the regulations in effect in the countries they operate in: child labour, slavery, forced labour, discrimination, worker health and safety, trade union rights, freedom of association, collective bargaining and compensation. Boralex expects its suppliers to enforce these rights in their operations;
- 2. Fulfil and apply the <u>Ten Principles of the UN Global Compact</u> on Human Rights, Labour, Environment and Anti-Corruption in all their endeavours;
- 3. Be mindful of their environmental footprint by complying with all applicable environmental laws and regulations and <u>Boralex's environmental mission</u>. Boralex also expects suppliers to support a precautionary approach to environmental challenges.
- 4. Conduct themselves in accordance with our <u>Code of Ethics</u>.

Suppliers are required to report any failure to comply with these commitments to Boralex. In addition, Boralex reserves the right to audit its suppliers without notice.
